

CIRCULAR:-

A reference is invited to the Ordinances, Regulations and Syllabi relating to the Master of Physical Education (M.P.Ed.) degree course vide Pamphlet No.213 and this office Circular No.UG/218 of 2000, dated 3<sup>rd</sup> July,2000 and the Head, University Department of Physical Education and the Principals of affiliated colleges in Physical Education are hereby informed that the recommendation made by the Ad-hoc Board of Studies in Physical Education at its meeting held on 16<sup>th</sup> September,2006 has been accepted by the Academic Council at its meeting held on 10<sup>th</sup> November,2006 vide Item No.4.17 and subsequently approved by the Management Council at its meeting held on 29<sup>th</sup> November,2006 vide Item No.9 and that in accordance therewith Regulation 4291 relating to the M.P.Ed. degree course is amended to read as under :-

**R.4291 :-** The candidate has to appear all the heads of examination at the M.P.Ed. (Parts I & II) (i.e. Theory, Practicals and dissertation). In case of candidate who does not appear or fails in M.P.Ed. (Part-I) examination (Theory and Practicals) and has satisfactorily kept the terms for the M.P.Ed. (Part-II) degree course will be permitted to appear for the M.P.Ed. (Parts-I & Part-II) examination simultaneously. However, the result of M.P.Ed. (Part-II) examination of a candidate who appeared simultaneously for M.P.Ed. (Parts-I & II) examinations will not be declared unless he passed the M.P.Ed.(Part-I) examination.

Further, that the amended Regulation 4291 relating to M.P.Ed. course will be brought into force with effect from the academic year 2007-20
