Sir,

I am to inform you that the recommendation made by, the Dean of the faculty of Arts in the matter of amendment of Ordinance 5291 and Regulation 4434 relating to the eligibility criteria and duration for the M.Phil degree in Defence and Strategic Studies has been accepted by the Academic Council, at its meeting held on 8th October, 2004 vide item No.4.27 and subsequently approved by the Management Council at its meeting held on 29th October, 2004 vide item No.22 and that in accordance therewith the Ordinance 5291 and Regulation 4434 has been amended to read as under :-

G.5291 Eligibility:-

Selection of officers for the Course as per Naval Headquarters requirement.

AND

Must have passed the Master's degree examination of this University or an examination of other University recognized as equivalent thereto or having undergone a one year course at any recognized War Staff College/Institution abroad or atleast two years structured training after joining the Defence Forces as a Graduate.

AND

At least 15 years Government service.

OR

Directing Staff borne or earlier served at the College of Naval Warfare.

OR

Eligibility for Foreign Military Officers selected to undergo Naval Higher Command Course will be based on their respective Country's equivalent qualification.

R. 4434 Duration

One year - (25 Weeks Contact period followed by 25 weeks of Distance learning in the form of Research and Dissertation writing). Directing staff borne or having earlier served at the College of Naval Warfare and officers who have already completed Naval Higher Command Course earlier will be required to follow only the Distance Learning Phase for Dissertation writing.

Further that the amended O.5291 and R. 4434 has been brought into force with effect from the academic year 2004-2005.
