(Part I & II) degree course vide Pamphlet No.175 and to this office Circular No.UG/205 of 2005 dated 27th May, 2005 and the Directors/Heads of the recognized Science Institutions concerned and the Principals of the affiliated colleges in the faculty of Science are hereby informed that the recommendation made by the Board of Studies in Botany at its meeting held on 18th December, 2006 has been accepted by the Academic Council at its meeting held on 5th March, 2007 vide item No.4.1 and that in accordance therewith the number of lectures allotted for the M.Sc. degree course in Botany, are as under :-

- (i) The number of lectures per theory at the M.Sc. (Parts I & II) in Botany shall be 4 lectures (one hour each)/per paper/week.
- (ii) The number of practical hours at the M.Sc. (Parts I and II) in Botany shall be 4 hours/week/per paper.
