

CIRCULAR: -

A reference is invited to the Ordinances, Regulations and syllabi relating to the Master of Science (M.Sc.) degree course vide Pamphlet No. 175 and to this office Circular No. UG/237 of 2008, dated 11th June, 2008 and the Directors/Heads, recognized Science Institutes concerned and the Principals of affiliated colleges in Science are hereby informed that the recommendation made by the Faculty of Science at its meeting held on 22nd February, 2010 has been accepted by the Academic Council at its meeting held on 3rd March, 2010 vide item No. 4.53 and subsequently approved by the Management Council at its meeting held on 4th June, 2010 vide item No. 26 and that, in accordance therewith, in exercise of the powers conferred upon it under sub section (i) of Section 55 of the Maharashtra Universities Act 1994, it has amended Regulation 5874 relating to the 'Standard of Passing at the M.Sc. Part I & Part II degree examination, is read as under.

Amended R.5874:

- a) A student who fails in theory papers (head of passing) and passes in practicals/internal assessment at M.Sc. Part I examination under scheme 'A' or 'B' will be permitted at his/her option to carry forward secured marks in practicals/internal assessment at subsequent examination.
- b) A student who fails in theory papers (head of passing) and passes in practicals/internal assessment at M.Sc. Part II examination under scheme 'A' or 'B' will be permitted at his/her option to carry forward secured marks in practicals/internal assessment at subsequent examination.
- c) A Student who wish to carry forward his earlier passing marks secured in practicals/internal assessment as above in (a) and/ or (b) will be entitled for award of class provided the student passes in theory papers (head of passing) at M.Sc. Part I examination in one sitting or M.Sc. Part II examination in one sitting.
- d) The earlier marks of practicals/Internal assessment at M.Sc. Part I and /or M.Sc. Part II examination shall be valid for four years from the year of registration at the M.Sc. degree course.

e) The Amended Regulation 5874 be made applicable to the students who appeared in April 2009 examination (first half of year

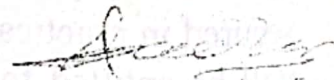
