I am to invite your attention to Ordinances, Regulations and Syllabi relating to the Master of Science (M.Sc.) (Home Science) degree course vide Pamphlet No.162 and to inform you that the recommendation made by the Ad-Hoc Board of Studies in Home Science at its meeting held on 20th April, 2007 has been accepted by the Academic Council at its meeting held on 10th August, 2007 vide Item No. 4.1 and subsequently approved by the Management Council at its meeting held on 16th August, 2007 vide Item No.53 and that in accordance therewith, Ordinance 5088 relating to the Master of Science (M.Sc.) degree course in Home Science is amended as under :-

O.5088 :- A candidate for being eligible for admission to the Master of Science (Home Science) course must have passed the Bachelor of Science (Home Science) Degree examination of this University or an examination of any other University recognized as equivalent thereto.

BRANCH I : HUMAN DEVELOPMENT

For being eligible for admission to the Master of Science (Home Science) degree course by papers in the branch of Human Development, a candidate must have passed either :

- a) Bachelor of Home Science with specialization in Human Development /Child Development
- b) Bachelor of Home Science (General)
- c) Bachelor of Arts : Psychology as a major /or as part fulfillment .
- d) Bachelor of Arts with Sociology as major
- e) Bachelor of Arts with Education as major
- f) Bachelor of Social work

BRANCH II : Foods, Nutrition & Dietetics

For being eligible for admission to the Master of Science (Home Science) degree course by papers in the Branch of Foods, Nutrition & Dietetics, a candidate must have passed either :-

- a) Bachelor of Home Science with specialization in Foods, Nutrition & Dietetics
- b) Bachelor of Home Science (General)
- c) Bachelor Science (B.Sc.)

BRANCH III : Textile and Fashion Technology

For being eligible for admission to the Master of Science (Home Science) degree course by papers in the Branch of Textile and Fashion Technology, candidate must have passed either :-

- a) B.Sc. (Home Science) with specialization in Textiles & Clothing
- b) B.Sc. with specialization in any branch of Home Science of the University of Mumbai
- c) Bachelor of Home Science (General)

Further that in exercise of the powers conferred upon the Management Council under Section 54(1) of the Maharashtra Universities Act 1994, amended Ordinance 5088 relating to the Master of Science (M.Sc.) degree course in Home Science has been brought into force with effect from the academic year 2007-2008.
