Sub-Centre, Ratnagiri and the Principals of affiliated colleges in the faculty of Arts, Science and Commerce are hereby informed that the recommendation made by the ad-hoc Board of Studies in Library and Information Science appointed by the Academic Council to advise it on all matters relating to the courses of study and examinations in Library and information science at its meeting held on 31st January, 2004 has been accepted by the Academic Council at its meeting held on 2nd April, 2004 vide item No.4.4 and subsequently approved by the Management Council at its meeting held on 17th April, 2004 vide item No.20 in exercise of the powers conferred upon it under Sub section (I) of Section 54 of the Maharashtra Universities Act and that in accordance therewith the Ordinance 5219 relating to the eligibility for appearing at the examination of Master of Library and Information Science Degree Course has been amended to read as under to provide for three weeks Internship course in Library:

Q.5219: A candidate desirous of appearing for the M.L.I.Sc. examination shall be permitted to do so on completion of an academic year after he/she has registered his/her name for the said course and produced evidence of having attended to the satisfaction of the Head of the Department, 3/4th of the total number of lectures delivered and seminars conducted and assignments per papers given in the subject of the examination.

The student shall have also completed the prescribed course of practical work, and to undergo three weeks Internship course in Library to the satisfaction of the Head of the Department, in order to go through the course of practical work satisfactorily, the students shall have attended at least three-fourths of the total number ofperiods assigned to the practical work.

The student shall have also completed the project work and its presentation as prescribed in the course syllabus.
