Unani degree course vide Pamphlet No.344 and to this office Circular No.UG/17 of 2003, dated 9th January, 2003 and to inform you that the recommendation made by the Ad-hoc Board of Studies in Unani Medicine and Surgery (B.U.M.S.) Kamil-e-Tib-o-Jarahat, Mahir-E-Tib(M.D.), Mahir-E-Jarahat (M.S.) at its meeting held on 4th March, 2004 has been accepted by the Academic Council at its meeting held on 2nd April,2004, vide Item No.4.48 and that has subsequently been approved by the Management Council at its meeting held 17th April 2004 (vide Item No.20) in exercise of powers conferred upon it under sub-section (i)Section (55) of the Maharashtra Universities Act 1994 and that in accordance therewith the Regulations 4242 relating to the M.D./M.S. (Unani) degree of Mahir-E-Tib and Mahir-E-Jarahat has been amended as under to provide for the nomenclature of the M.D. subject at Scrial No.7 as MAHIR-E-TIB (Doctor of Medicine) M.D. in ILMUL QABALAT-WA AMRAZ-E-NISWAN, WA NAUMAULUD instead of MAHIR-E-TIB (Doctor of Medicine) M.D. in AMRAZ-E-NISWAN as directed by the Central Council of Indian Medicine .:-
