Sir,

I am to invite your attention to the Ordinances, regulations and syllabi relating to the Post-graduate Diploma in Information Technology (PGDIT) course vide Pamphlet No.333 and to this office Circular No.UG/36 of 2001 dated 25th January, 2001 and to inform you that the following recommendations made by the Board of Studies in Physics at its meeting held on 14th November, 2003 has been accepted by the Academic Council at its meeting held on 3rd January, 2004 vide item No.4.10 and subsequently approved by the Management Council at its meeting held on 28th January, 2004 vide item No.22 in exercise of the powers conferred upon it under Sub Section (i) of section 55 of the Maharashtra Universities Act 1994, and that Regulation 4364 relating to the standard of passing for the Post-graduate Diploma in Information Technology (PGDIT) course is amended and now reads as under :-

R.4364:- (i) In order to pass the Semester I examination, candidates should secure a minimum of 40% marks in each of the theory papers (I to III) separately, and a minimum of 40% marks in each of the Practical (I to III) separately, with the minimum of 50% marks in the aggregate.

(ii) In order to pass the Semester II examination, candidates should secure a minimum of 40% marks in each of the theory papers (IV to VI) separately, and a minimum of 40% marks in each of the Practical (IV to VI) separately, a minimum of 40% marks in the Project Dissertation with the minimum of 50% marks in the aggregate.

(iii) A successful candidate will be placed in the First Class with Distinction if he/she secures 70% aggregate marks of Semester I and Semester II examinations taken together.

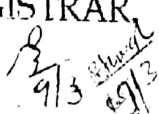
(iv) A successful candidate will be placed in the First Class if he/.she secures 60% aggregate marks of Semester I and Semester II examinations taken together.

- (v) A successful candidate securing less than 60% aggregate marks of Semester I and Semester II examinations taken together will be placed in the Second Class.
- (vi) Such a candidate who fails in any particular theory paper/s. practical/s at the First Semester Examination will be allowed to keep terms for Semester II as well as appear again for that/those theory paper/s. practical/s alongwith the Semester II examination. However, his/her result at the Semester II examination will be declared only after he/she clears the Semester I examination fully.
- (vii) The results will be declared at the end of the each semester examinations a candidate who fails to pass the semester I/Semester II examination will be allowed to appear for the corresponding theory Papers/Project/Practical only for two subsequent examinations held within the next academic year failing which the candidate is required to take fresh admission.
- (viii) The Post-graduate Diploma in Information Technology (PGDIT) shall be conferred at a convocation as per Statute 403 at the end of the course on the candidates who pass both the Semester examinations and satisfy the Passing Standards as stipulated under the above clauses (i) to (viii)

Further that the amended Regulation 4364 will be brought into force with effect from the academic year 2004-2005.
