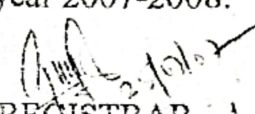


CIRCULAR :

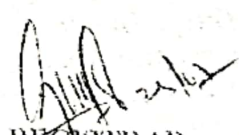
