Appendix B Question paper patterns for the 5 theory papers T.Y.B.A. Revised syllabi in Psychology (To be brought into effect from the academic year 2005-2006)

Paper IV Psychological Testing and Statistics 100 marks Duration = 3 hours

There will be 5 questions in each Section, 10 questions in all. Three questions from each Section, 6 questions in all, are to be attempted.

Question no. 1 in Section I On Topic I (<u>Psychological Testing</u>, <u>Assessment and Norms</u>) and Question no. 10 in Section II On Topic X (<u>Correlation</u>) carry 18 marks and are <u>compulsory</u>.

The remaining 8 questions carry 16 marks each. Any 4 questions are to be attempted out of these 8 questions, 2 questions from each Section.

Section I – Psychological Testing - Q. No. 1, 2, 3, 4, and 5, on the 5 respective topics. All 5 questions will be essay-type. A-B type of question (9 + 9 or 8 + 8 marks) may be asked, but not more than 1 out of the 5 questions in Section 1. Section II Statistics

O. 6. a = 3 marks. Theoretical question

b = 10 marks. Preparing a Frequency Distribution

c = 3 marks. Plot a Frequency polygon or a Histogram

Q. 7.a = 3 marks. Theoretical question b = 5 + 5 + 3 = 13 marks. Calculation of Mean, median and mode

Q. 8. a = 3 marks. Theoretical question
b. = 9 marks Calculation of QD or SD
2. + 2 marks. Calculation of 1. Pagagntile and 1. 0.

c. 2+2 marks. Calculation of 1 Percentile and 1 Percentile Rank

Q. 9. Theoretical question - On Topic IX; Write Shot Notes - any 4/6, each for 4 marks.

Q. 10. a. = 4 marks Theoretical question

b. = 13 marks. Calculation of rho by Spearman's rank-difference method

c. = 1 mark. Interpretation of answer

Paper V Abnormal Psychology 100 marks; Duration = 3 hours

There will be 4 questions in Section I and 4 questions in Section II.

All the 8 questions carry 20 marks.

In all 5 questions are to be attempted, but <u>not more than 3</u> questions from a single Section. Thus, the students can answer 'Any 3 questions from Section I and any 2 questions from Section II' or 'Any 2 questions from Section I and any 3 questions from Section II'.

Q. No. 1 in Section I and Q. No. 5 in Section II will be -

Write any 4 Short Notes out of 6, Or Answer any 4 short questions out of 6, each for 5 marks.

Q. No. 1 and Q. No. 5 will be based on 2 different topics within the respective Section, with 3 Short Notes/Short Questions from each of the 2 topics.

The combination of these 2 topics will change across the 3 sets of Question papers within a year.

Q. 2, 3, and 4 in Section I, and Q. 6, 7, and 8 in Section II will be full-length, essay-type.

Out of the 5 topics in each section, the Questions on Topics III (Anxiety Disorders: Panic, Phobias, Generalized Anxiety Disorder, PTSD and OCD) and V (Personality Disorders) in Section I and on Topics VI (Mood Disorders and Suicide) and VII (Schizophrenia) in Section II will be full-length, essay-type.

The other full-length essay-type question in each Section will be on the remaining one topic within the respective Section, which is not covered in Q. No. 1 and Q. No. 4.

Paper VI Industrial and Organizational Psychology; 80 marks; Duration = 2 1/2 hours

There will be 3 questions in Section I and 3 questions in Section II.

Any 2 out of the 3 questions from each Section, 4 questions in all, are to be attempted.

All the 6 questions carry 20 marks.

Q. No. 1 in Section I and Q. No.4 in Section II will be -Q. No. 1 in Section Notes out of 6, Or Answer any 4 short questions out of 6, each for 5 marks. Write any 4 Shows Will be based on 2 different topics within the respective Section, with 3 Short Notes/Short Questions from each of the 2 topics. Notes/Snot Question of these 2 topics will change across the 3 sets of Question papers within a year. Q. 2 and 3 in Section I, and Q. 5 and 6 in Section II will be full-length, essay-type. Q. 2 and 3 in Section, the Questions on Topic II in Section I - 'Understanding Out of the 4 topics in each section, the Questions on Topic II in Section I - 'Understanding Out of the 4 topic VIII in Section II - 'The Organization of Work Behaviour' will be fulllength, essay-type.

The other full-length essay-type question in each Section will be on the remaining one topic within the respective Section, which is not covered in Q. No. 1 and Q. No. 4.

Q. 2. Full-length essay-type question on Topic II

Paper VII Cognitive Psychology 100 marks; Duration = 3 hours

The Question paper pattern will be similar to that of Paper V - Abnormal Psychology.

Out of the 5 topics in each section, the Questions on Topics III (Paying Attention) and V (Retrieving Memories from Long-Term Storage) in Section I, and on Topics VIII (Visual Imagery) and X (Making Decisions) in Section II will be full-length, essay-type.

The other full-length essay-type question in each Section will be on the remaining one topic within the respective Section, which is not covered in Q. No. 1 and Q. No. 4.

Paper IX Counseling Psychology; 80 marks; Duration = 2 1/2 hours

The Question paper pattern will be similar to that of Paper VI - Industrial and Organizational Psychology.

The Questions on Topic IV in Section I - 'In-Depth exploration' and on Topic VIII in Section II - 'Major theories of counseling' will be full-length, essay-type.

The Questions on the remaining 6 topics can be full-length essay-type or Short Notes/Short Questions, depending on which 2 topics are covered in Q. No. 1 and Q. No. 4.
