No. BUC 1088 (2029) dated 30th November 1996 issued by Government of Maharashtra for Indian students and Rs. 15,000/- per year for foreign students with effect from the academic year 2008-2009 and other fees shall remain the same as on present.

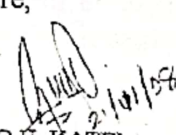
