

- Submitted files should be in Microsoft Word format. All text, footnotes, references, and appendices (as appropriate) must be single-spaced, 12-point Times New Roman font, no hyphenation. Use italics rather than underlining (except with URL addresses).
- All illustrations, figures, and tables should be placed within the text at the appropriate points, rather than at the end. Page margins should be a minimum of one inch.
