The Directors / Heads of the University Departments / Institutes/Centres, the Principal of all affiliated colleges, the I/c Principal, Sir J.J. College of Architecture, the I/c Librarian, University Library and the Officers in-charge of the different Sections/ Units of the Registrar's Office are hereby requested, as per the directions of the Hon'ble Vice-Chancellor, to invite application from the teachers by Circulating this Circular and forward the name/s of the eligible/interested teachers with the copies of their bio-data for considering them for nomination to the post of Director of National Service Scheme in the University of Mumbai for a term of three years. The age of the candidate aspiring for the nomination to the post of Director of National Service Scheme at the time of nomination shall not be more than 50 years.

The terms and conditions of service of the Director of National Service Scheme shall be the same as the terms and conditions of service of his original post and shall not be altered to his disadvantage during his tenure as the Director of National Service Scheme. On nomination as the Director of National Service Scheme, the pay last drawn by him on his original substantive post shall be protected. The person nominated as the Director of National Service Scheme shall hold a lien on the substantive post held by him prior to the nomination and he shall stand retired from his original post in accordance with the terms and conditions of service of that post.



NOTIFICATION

MAHARASHTRA PUBLIC UNIVERSITIES ACT, 2016.

No. Parini. 2018/C.R.86/Vishi-2.—In exercise of the powers conferred by sub-section (10) of section 72 read with clause (a) sub-section (2) of section 23 of the Maharashtra Public Universities Act, 2016 (Mah. Act. No. VI of 2017), the Government of Maharashtra hereby, prescribes the following Uniform Statute relating to emoluments, tenure and terms and conditions of service of the Director of National Service Scheme, namely:—

UNIFORM STATUTE NO. 2. OF 2018.

- Short title.— This Statute may be called the Maharashtra Public Universities (Emoluments, Tenure and Terms and Conditions of Service of the Director of National Service Scheme) Uniform Statute, 2018.
- Procedure for Nomination.— The Vice-Chancellor shall invite applications from the eligible aspiring candidates and shall nominate a suitable person as the Director of National Service Scheme from amongst them for a tenure of 3 years, which may be renewed for one more term.

The parent college or parent recognized institution or the parent university, in such case, shall be eligible to appoint the substitute person during the deputation period as per the prevailing norms.

- 3. Emoluments.— The person nominated as the Director of National Service Scheme shall be entitled to receive the parent college or parent recognized institution or the parent university, the same emolument and pay-scale which he was drawing in his previous service on the date of nomination as the Director of National Service Scheme.
- 4. Age.— Age of the candidate aspiring the nomination to the post of Director of National Service Scheme at the time of nomination shall not be more than 50 years.
- 5. Terms and Conditions of Service.—(1) Terms and conditions of service of the Director of National Service Scheme shall be the same as the terms and conditions of service of his original post and shall not be altered to his disadvantage during his tenure as the Director of National Service Scheme.
- (2) On nomination as the Director of National Service Scheme, the pay last drawn by him on his original substantive post shall be protected.
- (3) The person nominated as the Director of National Service Scheme shall hold a lien on the substantive post held by him prior to the nomination and he shall stand retired from his original post in accordance with the terms and conditions of service of that post.
- (4) The Director of National Service Scheme shall work directly under the supervision and control of the Vice-Chancellor.
- (5) The Director of National Service Scheme may, by writing under his signature addressed to the Vice-Chancellor, after giving one month's notice resign from his office and shall cease to hold his office on the acceptance of his resignation by the Vice-Chancellor or from the date of expiry of the said notice period, whichever is earlier.
- (6) The Director of National Service Scheme may be relieved from his office by the Vice-Chancellor by giving one month's notice in writing.
