The Principals/Directors of all the affiliated Colleges/Institutions are hereby informed that University Grant Commission (Conferment of Autonomous Status upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 have been notified by the Government of India in the official Gazette on 12<sup>th</sup> February, 2018, and the same is available on the UGC website, [www.ugc.ac.in](http://www.ugc.ac.in) with respect to Conferment of Autonomous Status upon the affiliated Colleges/Institutions.

In this connection it is hereby informed that the Conferment of Autonomous Status and implementation of the same shall be guided by the above-mentioned UGC Regulations 2018, which are accepted by the State Government vide Resolution No. स्वायत्त २०१८ /प्र.क्र. १७६/ १८ /विशी-३ dated: 28<sup>th</sup> May, 2018. These Regulations shall apply to all the affiliated Colleges / Institutions of University of Mumbai seeking the conferment of Autonomous College status.

It is therefore brought to the notice of all the affiliated Colleges/Institutions that if they wish to apply for Conferment of Autonomous Status, shall apply to the University of Mumbai in accordance with the UGC Regulations, 2018.
