Attention of the Principals of the Affiliated Colleges, the Head University Departments and Directors of the recognized Institutions in Humanities Faculty is invited to this office circular No.UG/46 of 2015-16, dated 4<sup>th</sup> August, 2015 relating to the syllabus for the Part time one year Advanced Diploma course in Buddhist Studies.

They are hereby informed that the recommendations made by the Board of Studies in Logic and Philosophy at its meeting held on 28<sup>th</sup> August, 2019 and subsequently approved by the Board of Deans at its meeting held on 1<sup>st</sup> October, 2019 vide item No.- 62 have been accepted by the Academic Council at its meeting held on 3<sup>rd</sup> October, 2019 vide item No. 4.7 and subsequently approved by the Management Council at its meeting held on 23<sup>rd</sup> October, 2019 (vide item No. 8) and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 74(4) of the Maharashtra Public Universities Act, 2016 (Mah. Act No. VI of 2017) and the amended Regulation 8836 relating to Qualification for teachers in Part time one year Advanced Diploma in Buddhist Studies – Vipassana Theory & Practice, has been brought into force with effect from the academic year 2019-20, accordingly.
