

Feature of Web- Based applications (software) to conduct Psychometric Assessment

- To create Web- Based applications to conduct Psychometric Assessment which can be accessed through web browsers such as Google Chrome, Internet Explorer and Mozilla Firefox on laptop, Desktop or Smart phones.
- The Web application will have Role based Access Management function to define roles and associated access to that particular role. (E.g. Super Admin can create multiple admins and assign specific access to them.)
- To test the candidate on aspects of Interest, Ability, Personality and Intelligence.
- Admin can also assign an evaluation type such as Likert Scale or Test Format for each section and/or each test.
- Admin can assign a weightage for each type of response
- Admin can add any number of tests of above type and sections in each test mentioned above.
- Admin can define the score range and add/change the feedback associated with it.
- Test to be created in 4 languages namely: English, Hindi, Marathi & Gujarati.
- Assessment system to be OTP based for candidate registration.
- To have provision for candidates to be able to take the test immediately or can save the responses/ answers to be continued later for the remaining questions.
- To generate the response report immediately in PDF format upon submission of the completed test. The report must be emailed to his/her registered email address.
- The report must be saved in the system so that the student can Re- login and access the report as per his/ her availability.
- The candidate report must be saved in the system and accessible at the administrative end of each candidate.
- The Application should be detailed and the test should transform the high-level requirement into details using case diagrams.


