The post of Assistant Professor is non vocational academic post at UGC Human Resource Development Centre of University of Mumbai. This post is not covered under the “Salary Payment Scheme” of the State Government and will continue subject to the continuation of scheme by University Grants Commission.

**A. Pay scale :** The present Pay scale of the post is as follows:-

Academic level 10- Entry pay of Rs. 57700/- + allowances

**B. Minimum Qualifications:-**

- 1) A Master’s degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- 2) Besides fulfilling the above qualifications, the candidates must have cleared the National Eligibility Test (NET) conducted by the UGC / CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standard and Procedure for Award of M.phil. / Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/ SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal; and
- e) The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars, sponsored/funded/supported by the UGC/ ICSSR CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic affairs) of the University concerned.

Note: NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted. However, Ph.D. degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines.

## **Relaxation in Qualification**

- (i) A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribes / Other Backward Classes (OBC)(Non-creamy layer)/ Differently abled, for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible based on only the qualifying marks without including any grace marks procedure.
- (ii) A relaxation of 5% may be provided (from 55% to 50% of the marks) to the Ph.D. degree holders who have obtained their Masters' degree prior to 19<sup>th</sup> September, 1991.
- (iii) A relevant grade which is regarded as equivalent of 55% wherever the grading system is followed by a recognized university at the master's level shall also be considered valid.
