(3 years) Sem.V and L.L.B.(5 years) Sem.IX.

They are hereby informed that the recommendations made by the Ad-hoc Board of Studies in Law at its online meeting held on 3<sup>rd</sup> February, 2021 vide item No.3 and subsequently passed by the Board of Deans at its online meeting held on 11<sup>th</sup> February, 2021 vide item No. 8.7 have been accepted by the Academic Council at its meeting held on 23<sup>rd</sup> February, 2021 vide item No. 8.6 and that in accordance therewith, replace Juvenile Justice Act 2000 by the juvenile Justice Act, 2015 which is a component in the syllabus of the paper Code of Criminal Procedure Juvenile Justice Act & Probation of Offenders Acts of Semester V of LL.B (3) yrs and Semester IX of LL.B (5 yrs) has been brought into force with effect from the academic year 2020-21, accordingly.
