They are hereby informed that the recommendations made by the Ad-hoc Board of Studies in Theatre Arts at its meeting held on 18th August, 2021 vide item No.1 (iii) and subsequently passed by the Board of Deans at its online meeting held on 23rd September, 2021 vide item No.8.4 (A) have been accepted by the Academic Council at its meeting held on 10th November, 2021 vide item No. 8.4 (A) and subsequently approved by the Management Council at its online meeting held on 30th December, 2021 vide item No. 3 and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 74(4) of the Maharashtra Public Universities Act, 2016 (Mah. Act No. VI of 2017) for the amendment of **R. 9261(A) relating to the Scheme of Examination for Certificate Course in Dance for Special Students**, from the academic year 2021-22, accordingly. Amendment of R. 9261(A) relating to the Scheme of Examination for Certificate Course in Dance for Special Students.

Existing R. 9261(A):-

- Internal evaluation will be done after each 15 to 20 days.
- The final evaluation will be conducted at the end of course.
- The syllabus will be focusing on practical dance training through which specific abilities and skills will improved.
- The scheme of evaluation will be on 'FIVE POINT GRADE SCALE' as follows:
 - 1: Poor
 - 2: Fair
 - 3: Good
 - 4: Very Good
 - 5: Excellent

Amended R. 9261(A):-

- Internal evaluation will be done after each 15 to 20 days.
- The final evaluation will be conducted at the end of course.
- The syllabus will be focusing on practical dance training through which specific abilities and skills will improved.


The scheme of evaluation will be on 'FIVE POINT GRADE SCALE' as follows:

- 1: Poor
- 2: Fair
- 3: Good
- 4: Very Good
- 5: Excellent

Awards of the Division and Passing

- A) A candidate shall be declared to have passed the Diploma in Acting Skills Examination if he passes in all the papers by securing not less than 40% marks in Theory, 50% marks in Practicals and 50% marks for Internal Assignments.
- B) I) A candidate shall be declared to have passed in Second Division if he secures 50% marks but less than 60% marks in the aggregate.
II) A candidate shall be declared to have passed in First Division if he secures 60% marks but less than 66% marks in the aggregate.
III) A candidate shall be declared to have passed in First Division with Distinction if he secures 66% and above in the aggregate.
