## Contributors

Indrani Bhattacharjee is Assistant Professor of Philosophy at the Jindal School of Liberal Arts and Humanities, OP Jindal Global University, Sonipat. She has doctoral degrees in philosophy from Jadavpur University and University of Massachusetts, Amherst. She has taught for close to nine years at Azim Premji University, and for shorter stints at Tufts and Bridgewater State University in the United States. While her writing and teaching are strongly influenced by her training in analytic philosophy, Indrani is also interested in exploring veins of philosophical enquiry that actively combine dialectical thought with the deliverances of a synoptic and/or poetic vision and imagination. Her research and teaching interests include the philosophy of the Later Wittgenstein, philosophy of education, epistemology and Indian aesthetics. Her dominant research interest at this time is the early philosophical thought of Rabindranath Tagore (circa 1908–1916), a topic on which she is writing a book. In this book, she explores the sources of Tagore's humanism and cosmopolitanism through his essays in Bengali and English.

His research interests are in moral, political, and legal philosophy on the one hand, and on Indian constitutional and intellectual history on the other.
