The Heads, University Departments, the Directors and Heads, Institutions concerned, the Principals of all the affiliated colleges and the Professor-cum-Director, Institute of Distance Education are hereby informed that the Regulation 6064 relating to the submission of Registration Forms for the Post Graduate Degrees/Diplomas has been accepted by the Academic Council at its meeting held on 13th February, 2009 vide item No.7.1 and subsequently approved by the Management Council at its meeting held on 20th February, 2009 vide item No.34 and that, in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 55(1) of the Maharashtra Universities Act, 1994, it has made Regulation 6064 relating to the submission of Registration Forms for the Post graduate Degrees/Diplomas of the University to read as under:-

"R. 6064: The last date for submission of application for registration duly completed in all respects to the University by Colleges/Recognized Institutions/University Departments and Institute of Distance Education in respect of students admitted by them to the Post graduate Degrees/Diplomas courses for which Registration fee has been prescribed will be 30th September every year.

Applications for Registration received by the University (after the last dated fixed for the purpose) is over i.e. between the period from 1st October to 30th November every year a late fee of Rs.150/- per application shall be charged.

Applications for Registration received during the period from 1st December to 31st December every year will be accepted on payment of a late fee of Rs. 200/- per application.

The Vice-Chancellor shall be authorized to consider other than above mentioned cases where there is delay on the part of Students/Colleges/Institutions in submission of registration forms time to time, as a special case on payment of a late fees of Rs.250/- per application.

The Registration numbers will not be allotted to the students whose Registration forms will be received by the University after 31st December every year. Those students who fails to submit their registration forms, will not be allowed to appear for examination."
