- 1) **Candidates whose names are mentioned in the first merit list are required to do online Registration** by making payment of Rs. 100/- on the following link : **(online registration from 09th November, 2022 to 19th November 2022).(Registration is part of Admission Process. Registration does not amount to Admission.)**

Note : a) LL.M. Admission process shall be subject to verification of documents. In case of incomplete submission of documents the candidate shall not be entitled for admission.

b)The Receipt of payment of Rs. 100/- should be submitted by the candidates to Department of Law at the time of Verification of document.

c) **Candidates are required to select the group on Parivartan portal <https://uomadmissions.mu.ac.in/>, as notified in the Merit List.**

- 2) For the purpose of Verification of document and Approval of admission, candidates are required to present their original documents for verification from **10th November, 2022 to 19th November, 2022 (Holiday on 12th & 13th November, 2022)** at the Department of Law, University of Mumbai, Fort, Mumbai-400032.

- 3) After verification of documents, office will approve the LL.M. admission of candidate. Then candidate will receive payment link on their E-mail through auto generated system. The candidate should complete online admission fee payment procedure through payment gateway provided by '**Parivartan Portal**'.
- 4) After successful payment of admission fees, the candidate should download their Admission Form and Receipt of payment from '**Parivartan Portal**.' The said Admission Form and Receipt should be submitted to Department of Law by the candidates and collect the Identity Card for the LL.M. Degree Programme.
- 5) Candidates whose names appear in the First merit list of LL.M. Admission should take their admission as per prescribed schedule. **It is mandatory to submit the admission form and Fee Receipt to the office of Department of Law. Failure to comply with the aforementioned conditions will render candidates ineligible for the admission process and the vacant seats will be filled up from the waiting list which will be subsequently drawn.**
