- Candidate should attach with application a D.D. of Rs.1000/- (non refundable) (Rs. 500/- in case of reserved category candidate) in favour of "**Registrar Kavikulguru Kalidas Sanskrit University, Ramtek.**" from any nationalize bank and payable at Ramtek only.
- Application will be required duly signed and enclosed attested clean photo copies of the certificate of their educational qualifications, experience, research experience, last pay details etc. to each set of an application.
- The last date for receipt of application in prescribed format duly completed in three copies is 07/01/2023 up to 5.40 p.m.
- The candidates who are already in service should apply through proper channel and bring NOC from the present employer (if changed at the time of interview), otherwise protection of pay and previous service could not be considered. They should furnish all the relevant information regarding their present service, legal proceeding of complaint, court cases, criminal cases, disciplinary action, if any, pending in r/o his/her existing appointment/ services.
