ALL APPLICATIONS ARE REQUIRED TO COMPLETE ADMISSION RELATED PROCESS ON 24/01/2023.

THE LL.M. ADMISSION PROCESS FOR THE ACADEMIC YEAR 2022-2023 IS CLOSED HEREWITH.

The candidates in Final Merit List are hereby informed that the list of candidates is notified on the MU website and displayed on the notice board. The Final Merit List is prepared according to the Merit and eligibility norms of the University of Mumbai. The candidates are required to remain present in the Department of Law **Room No. 123 at 02.00 p.m. on 24th January, 2023.**

Admission process will start by calling upon candidates as per waiting merit list for admission and after verification of documents, seat will be allotted as per vacant seat available in particular category of each group.

LL.M. Admission process shall be subject to verification of documents. Candidates are required to keep ready with all relevant scanned documents and hard copy of documents for the purpose of verification of documents. If Candidates fail to submit their scanned documents, admission on specified time allotted to him / her then, his / her claim for admission will be cancelled.

If candidate is absent when called upon for admission the opportunity will be given to the next candidate present in the Room No. 123 of the Law Department and also vacant seat will be allotted to next candidate as per waiting merit list.

After confirmation of admission Candidates in the Final Merit List are required to do online Registration immediately and comply with the necessary Admission procedure.

- 1) The candidate are required to do online Registration by making payment of Rs. 100/- after allotment of seat on the above link : (online registration) Registration is part of Admission Process to Admission.)**
- 2) The Receipt of payment of Rs. 100/- should be submitted by the candidates to the Department of Law at the time of admission.**
- 3) On submission of Rs. 100/- receipt of registration, office will approve the LL.M. admission of candidate. Then candidate will receive payment link on their Parivartan Portal login through auto generated system. The candidate should complete online admission fees payment procedure through payment gateway provided by 'Parivartan Portal'.**

- 4) After successful payment of admission fees, the candidate should download their Admission Form and Receipt of payment from 'Parivartan Portal.' The said Admission Form and Receipt should be submitted to Department of Law by the candidates and collect the Identity Card for the LL.M. Degree Programme.
- 5) It is mandatory to submit the admission form and Fee Receipt to the office of Department of Law. Failure to comply with the aforementioned conditions will render candidates ineligible for the admission.
