ACADEMIC YEAR 2022-23**

It is hereby notified for information of students registered for the different Post-Graduate courses in the Affiliated colleges and Recognized Institutions and all the Heads/Directors of the University Departments that the University awards some Merit Scholarships and free studentships to eligible students, prosecuting studies for Post Graduate courses By Papers. The value of the Merit scholarships is Rs. 1500/- per annum and free studentships is equal to the Tuition fee prescribed by the University but not more than the value of Merit Scholarships. Application for the said awards is required to be made on a prescribed form which can be had from the Admission Enrollment, Eligibility and Migration Department, 1<sup>st</sup> Floor, Dr, Babasaheb Ambedkar Bhavan, Vidyanagari, Kalina, Santacruz (E), Mumbai - 400 098.

Application completed in all respects, must be submitted in the University office Admission Enrollment, Eligibility and Migration Department on or before **15<sup>th</sup> January, 2023** during working hours.

2. Price of the Rs. 15/- per form.
3. Kindly furnish the information about the percentage of marks in details. Detail percentage of marks of each students be furnished alongwith the covering letter. Otherwise the form will not be considered.
4. Those students who have completed their P. G. Course Part -I (Sem I & II) in the academic year 2021-22 & students who have completed their P. G. degree (Sem III & IV) in the academic year 2021-22 are eligible for the said Scholarship.

- 5. Incomplete applications as well as those received after prescribed date will not be entertained.
- 6. The Candidates receiving any other Freeship or course fee shall not be considered for the award of Free Studentship. Candidates from the reserve category shall not ordinarily be considered for the award of free studentship, as they are entitled to receive the Freeship from the State Government.
- 7. No payment of Scholarship shall be made unless the candidate has attended minimum 75% lectures and practicals etc. for the course.
- 8. Information about 75% lectures and practicals etc, for the course certified by the Principal of the college should be attached alongwith the application.
