NCLT is a quasi-judicial authority incorporated for dealing with corporate disputes that are of civil nature arising under the Companies Act pertaining to claims of oppression and mismanagement of a company, winding up of companies, and all other powers prescribed under the Companies Act.

The NCLT has the power to hear and decide the cases relating to various matters such as mergers and acquisitions, oppression, and mismanagement, winding up of companies, and other matters related to corporate laws.
