CIRCULAR:-

Attention of the Principals of the Affiliated Colleges, Directors of the Recognized Institutions and the Head University Departments in Faculty of Interdisciplinary Studies is invited to this office circular Nos.UG/237 of 2009 dated 23rd June, 2009 and UG/198 of 2019-20 dated 17th March, 2020 relating to the M.P.A. (Music).

They are hereby informed that the recommendations made by the Ad-hoc Board of Studies in Music at its meeting held on 23rd August, 2022 vide item No. 5 and subsequently passed by the Board of Deans at its online meeting held on 08th December, 2022 vide item No. 8.15 (A) have been accepted by the Academic Council at its meeting held on 06th April, 2023 vide item No. 8.15 (A) and subsequently approved by the Management Council at its online meeting held on 27th April, 2023 vide item No. 11 and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 74(4) of the Maharashtra Public Universities Act, 2016 (Mah. Act No. VI of 2017) for the amendment of **R. 4269 and R. 4270 relating to the standard of passing for M.P.A. (Music)** from the academic year 2023-24 and to read as under :-

Amendment of R. 4269 and R. 4270 relating to the standard of passing for M.P.A. (Music).

Existing R. 4269 –

To pass the examination for each of the Part I and Part II a candidate must obtain 40% of the full marks in each theory paper, a minimum of 50% marks in Internal Assessment 50% of full marks in each practical and 50% of the aggregate marks in each part.

Existing R. 4270 –

- (i) Those of the successful candidates who obtain 50% more of the total marks in Part-I and Part-II examination taken together will be placed in the 'C' Grade, those who obtain 60% or more of the total marks will be declared to have passed the examination in 'A' Grade. Those who obtain 80% or more marks will be declared to have passed the examination in 'A' Grade with Distinction.
- (ii) An unsuccessful candidate shall be allowed to reappear for all the theory and/or practical papers directly without taking re-admission and his/her Internal Assessment marks shall be

carried forward if the candidate has passed the Internal Assessment and he/she claim the grade, prize or scholarship at examination.

(iii) A candidate who fails in Internal Assessment has to take re-admission in the same class.

Amended R. 4269 –

To pass the examination for each of the Part I and Part II a candidate must obtain 40% of the full marks in each theory paper, a minimum of 40% marks in Internal Assessment 40% of full marks in each practical and 40% of the aggregate marks in each part.

Amended R. 4270 –

- (i) Those of the successful candidates who obtain 40% more of the total marks in Part I and part II examination taken together will be placed in the 'C' Grade, those who obtain 60% or more of the total marks will be declared to have passed the examination in 'A' Grade. Those who obtain 80% or more marks will be declared to have passed the examination in 'A' Grade with Distinction.
- (ii) An unsuccessful candidate shall be allowed to reappear for all the theory and/or practical papers directly without taking re-admission and his/her Internal Assessment marks shall be carried forward if the candidate has passed the Internal Assessment and he/she claim the grade, prize or scholarship at examination.
- (iii) A candidate who fails in Internal Assessment has to take re-admission in the same class.
