**FIRST MERIT LIST**

The candidate is required to collect the **Admission form** in Room No. 126, First Floor, Department of Law, University of Mumbai, Fort Campus, Mumbai – 400 032.

The candidate is required to submit (02) copies of Pass port size photograph.

**VERIFICATION OF DOCUMENTS**

- 1) The candidates should fill up admission form in **Room No. 208, Second Floor, Department of Law, University of Mumbai, Fort Campus, Mumbai – 400 032., from 25<sup>th</sup> October, 2023 to 1<sup>st</sup> November, 2023 .( except Lunch Break from 1.00 p.m. to 1.30 p.m.).**
- 2) LL.M. Admission is subject to verification of documents. In case of incomplete submission of documents the candidate is not eligible/entitled for admission.
- 3) Pre-Registration Form should be attached with the Admission form at the time of Verification of document.

- 4) For the purpose of Verification of document and Approval of admission, candidates are required to present their original documents for verification.
- 5) After verification of documents, office will approve the LL.M. admission of candidate.
- 6) The Candidate is required to draw Demand Draft in favour of "The Finance and Accounts Officer, University of Mumbai," payable at Mumbai and submit the same to the Department of Law, Room No. 209, Second Floor, University of Mumbai.
