LL.M. SECOND YEAR ADMISSION **(2023-2024)**

- 1) All students should note that the LL.M. Second year admission for A.Y. 2023-24 is on **Provisional Basis**.
- 2) For LL.M. second year provisional admission the students are required to visit Department of Law with following documents :
 - A) **Provisional Admission form**
 - B) **Undertaking form**
 - C) **LL.M. Sem I marksheet**
 - D) **LL.M. Sem II hall ticket**
 - E) **(Caste certificate, Caste validity, non-creamy layer certificate for category students). 02 Sets**
 - **O.5239.** A candidate for being eligible for admission to the **Third and Fourth Semester must have either passed in the First and Second Semester or must have got exemption in at least six papers of the First and Second Semester.**
 - **O.5240.** Unless students pass all the theory papers and practical paper of third Semester examination and dissertation of the Fourth Semester, their final result shall not be declared.
 - **O.5241.** Admission for the students of Backward classes shall be in accordance with the Government Policy. Students applying for admission under the reserved category other than SC/ST are required to submit non creamy layer certificate along with their application form. Students applying for admission for other reservation will be admitted as per the government policy from time to time.
- 3) LL.M. Second year Provisional admission fees is **Rs. 500/-**.
- 4) All students must note that in order to confirm the Provisional admission the students are required to visit Department of Law office **once the Sem II results are declared**. They are required to produce the necessary documents like :
 - A) **Sem I & Sem II marksheet ,**
 - B) **Prov admission fee receipt**
 - C) **Caste certificate, Caste validity, non-creamy layer certificate for category students & fill the online form for LL.M. Second year & pay necessary & requisite admission fees online.**
