Memorandum of Understanding (MOU)

This Memorandum of Understanding (MOU) is entered into on <u>19.10.2023</u>, by and between **Mumbai University**, located at Mahatma Gandhi Marg, Fort, Mumbai 400032, hereinafter referred to as the "Mumbai University," and **Dr. Homi Bhabha State University**, located at Mahatma Gandhi Road, Fort, Mumbai- 400032, hereinafter referred to as the "Dr. Homi Bhabha State University."

And

DR. HOMI BHABHA STATE UNIVERSITY, Mumbai, Dr. Shyama Prasad Mukherjee Chowk, Mahatma Gandhi Road, Fort, Mumbai-400032.

1. Purpose:

The purpose of this Memorandum of Understanding is to establish a collaborative partnership between Mumbai University and Dr. Homi Bhabha State University for the shared use of Mumbai University's playground and other facilities to organize sports competitions for Dr. Homi Bhabha State University.

2. Scope of Agreement:

2.1. Access to Facilities:

- a. Mumbai University agrees to provide Dr. Homi Bhabha State University with access to its playground, sports fields, and other related facilities as and when requested, subject to the terms and conditions outlined in this MOU.
- b. Dr. Homi Bhabha State University shall have the right to use the specified facilities for the purpose of organizing sports competitions during the duration of this MOU.

2.2. Schedule of Use:

- a. Both parties shall cooperate to establish a schedule for the use of the facilities, taking into account the academic and sports calendars of both universities.
- b. The schedule shall be agreed upon in advance for each academic year to ensure fair and equitable access.

3. Financial Arrangements:

- a. Mumbai University agrees to provide the facilities to Dr. Homi Bhabha State University at a very nominal cost, as specified from time to time.
- b. Dr. Homi Bhabha State University shall accept responsibility for any damages to infrastructure, equipment etc caused by the specific use of such assets belonging to Mumbai University by way of its usage by Dr. Homi Bhabha State University during the conduct of any event by Dr. Homi Bhabha State University, if proven beyond reasonable doubt, and will agree to settle claims in this respect through mutual understanding.

4. Term:

5. Responsibilities of the Parties:

- a. Both parties agree to uphold the principles of fair play, sportsmanship, and respect for each other's facilities and property.
- b. Mumbai University shall ensure that the facilities are in good, safe, and usable condition at all times.
- c. Dr. Homi Bhabha State University shall adhere to any specific rules and regulations set by Mumbai University regarding the use of the facilities.

6. Confidentiality:

Both parties agree to keep the details of this MOU confidential, unless required to disclose information by law.

7. Termination:

Either party may terminate this MOU with written notice to the other party in case of a material breach of its terms by the other party.

8. Amendments:

Any amendments or modifications to this MOU shall be made in writing and require the mutual consent of both parties.

9. Governing Law:

This MOU shall be governed by and construed in accordance with the laws of Maharashtra/India.

10. Entire Agreement:

This MOU constitutes the entire understanding between the parties and supersedes all prior understandings, whether written or oral.
