The G1 World University Taekwondo Festival 2024 is scheduled to be held at the Gymnasium of Keimyung University, Daegu City, Korea from 05-11 July 2024. The India Taekwondo has entrusted the responsibility of conducting the selection trials for the Indian Taekwondo (Men/Women) Teams at Shri Jagdishprasad Jhabarmal Tibrewala University, Jhunjhunu.

In this connection, you are requested to send the entries of eligible Taekwondo players (Men/Women) from your university to participate in the selection trials of the Indian Taekwondo Team (Men & Women) scheduled on 31st May to 1st June 2022 at Shri Jagdishprasad Jhabarmal Tibrewala University, Jhunjhunu as specified below.

Reporting on 31st May 2024 will be from 4:00 – 6:00 pm.

The players attending the selection trials should produce the following documents at the time of selection trials:

1. All India Inter University Medalist of the past two years.
2. Junior/Senior National Championship Medalist of the past two years.
3. International Player who represented the Indian Team in any Graded Event
4. Outstanding performer Athlete.
5. Age between 18-27 years (1996-2006).
6. Eligibility proforma of athlete duly signed by the Authorities (Two copies).
7. Identity Card of the Current Academic Session.

A registration fee of Rs.1000 per athlete is applicable. Lodging and boarding facilities will be provided at the University campus during the selection trials at a charge of Rs. 500/- per day/per person. Please note only Veg food will be provided.

Team In-Charge/Captains should report with all the above Eligibility at the Sports Office, Shri Jagdishprasad Jhabarmal Tibrewala University, Jhunjhunu on 25th May 2024 and confirm their entries by email at usb@jjtu.ac.in

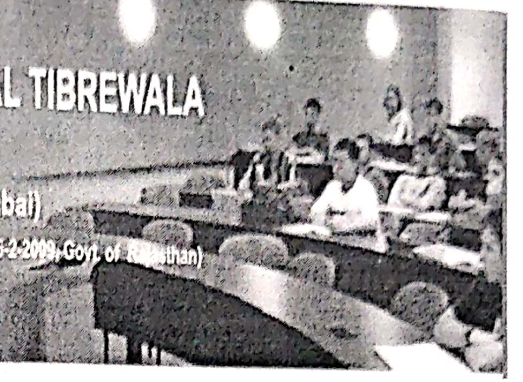
