The Director, Jamnalal Bajaj Institute of Management of Studies and the Directors, the recognised Management Institutes are invited to the Ordinances, Regulations and Syllabi relating to the part-time (Three year) Master Degree 1) Marketing Management (M.M.M.) 2) Financial Management (M.F.M.) and 3) Administrative Management (M.A.M.) vide pamphlet Nos. 103, 104 and 105 respectively and to this office Circulars No. UG/155 dated 11<sup>th</sup> July, 1990. No. UG/276 dated 15<sup>th</sup> June, 1994 and No. UG/585 dated 12<sup>th</sup> December, 1994 and Circular No. UG/144 of 1998, dated 6<sup>th</sup> May, 1998 relevant to M.F.S.M.

Nomenclature of the part-time Master's degree course in Administrative Management be changed to the "Master's degree in Human Resources Development Management (MHRDM)" <u>vide</u> Circular No. UG/75 of 1995, dated 15<sup>th</sup> February, 1995.

M.I.M. degree programme be introduced w.e.f. the Academic Year 2001-2002 and that the Ordinances and Regulations for the 3 year part-time Master's degree in Information Management (MIM) be as per the courses of M.A.M./M.F.M. & M.H.R.D.M. vide Circular No. UG/427 of 2000, dated 21st December, 2000.

O.6122 relating to eligibility criteria for admission and Regulations 8749. 8750, 8751 and 8752 relating to the Standard of passing and ATKT respectively for the Three Year Part-Time MFM/MMM/MHRDM/MIM degree programmes as per the Credit Based Semester and Grading System are introduced <u>vide</u> Circular No. UG/25 of 2014, dated 8<sup>th</sup> August, 2014.

Further, I am to hereby informed that the recommendations made by the Board of Deans at its meeting held on 8<sup>th</sup> August, 2019 have been accepted by the Academic Council at its meeting held on 3<sup>rd</sup> October, 2019 (vide item No. 8.1) and subsequently approved by the Management Council at its meeting held on 23<sup>rd</sup> October, 2019 (vide item No. 18) and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 74 (4) of the Maharashtra Public Universities Act, 2016 (Mah. Act No. VI of 2017) as per General Instructions in The Gazettee of India published by authority, New Delhi, Saturday, July 5 – July 11, 2014 (asadha 14, 1936) and Ordinances relating to the title (Nomenclature) of the various Under Graduate & Post Graduate Courses run by the Jamnalal Bajaj Institute of Management of Studies and the Directors, the recognised Management Institutes are amended.
