The position is initially for eight months or until the project's completion.

Candidates should report to the Department of Life Sciences, University of Mumbai, Santacruz (E), Mumbai- 400 098, on 25th July 2024 at 11:00 AM for a Walk-in Interview with originals and photocopies of the relevant documents.

Eligibility:

1. M.Sc. in Life Science or allied subjects with at least First class or 60% marks (55% for SC/ST) or equivalent CGPA.

OR

2. M.Pharm. Degree (Pharmacology or any appropriate branch with relevant research experience and scientific writing skills).

OR

3. B. U. M. S. / M. D. Unani degree (Moalijat or any appropriate branch with relevant research experience and scientific writing skills).

Desirable experience: Previous research experience conducting in vitro and in vivo bioassays would be preferred.

Stipend: The JRF will be paid consolidated monthly remuneration of Rs. 31 000/- pm + HRA (24% of basic)

Age limit: The candidate should be no older than 28 as of the date of the interview.

Further instructions:

1. Application without supportive documents asked for shall be summarily rejected.
2. Qualifications and experience should be in a relevant discipline/field and from a reputed institution/organization recognized by the relevant authority. Documents/certificates will be verified before the interview.
3. Submission of incorrect or false information during the walk-in interview process shall disqualify the candidature at any stage.
4. No TA/DA will be paid.
5. The authority reserves the right to accept or reject the candidature without assigning a reason. Canvassing in any form will disqualify the candidate
6. The Project is in its third and final year of tenure, and the fellowship due for the Candidate will be made available as soon as the concerned Donor Agency releases the funds.
