 - E) (Caste certificate, Caste validity, non-creamy layer certificate for category students). All documents (02 Sets)
- O.5239.A candidate for being eligible for admission to the Third and Fourth Semester must have either passed in the First and Second Semester or must have got exemption in at least six papers of the First and Second Semester.
- **O.5240**. Unless students pass all the theory papers and practical paper of third Semester examination and dissertation of the Fourth Semester, their final result shall not declared.
- **O.5241**. Admission for the students of reserved categories shall be in accordance with the Government Policy. Students applying for admission under the reserved category other than SC/ST categories are required to submit valid non creamy layer certificate along with their application form. Students applying for admission for other reservation will be admitted as per the government policy from time to time.
- 2) LL.M. Second year Provisional admission fees is Rs. 500/- (in Cash)
- 3) All students must note that in order to **confirm** the Provisional admission the students are required to visit Department of Law office **once the Sem II Revaluation results (FH 2024)are declared**. They are required to submit the necessary documents to the Dept of Law like:
