- For the foreign students who are not going to stay in India, after their graduation
 - i) 2 Credits AEC for Sem II & III course of French/ German language will be made available, (only if foreign students are not going to the stay in India after completion of their study, an affidavit/undertaking be taken from the student that he is not going to stay in India after completion of UG degree.)
- b) For the foreign students who are going to stay in India after their graduation
 - i) 2 Credits Arabic, Persian, Urdu, Hindi, My Marathi from German Department, AEC for Sem II & III can be made available to the foreign students
- c) For the students who are diagnosed with language learning Disability (Dislexia) may be considered for same Ability Enhancement Courses, but the evaluation can be in a lenient way, original circular No. Exam/92 of 2006 may also be applied in such cases.
