Interview for admission to Ph.D. Programme in Law 2024-25

Candidates desiring to pursue Ph.D in Law are hereby informed that date for Ph.D. Interview is scheduled on 23rd and 24th April 2025 (10.30 a.m. to 5.00 p.m.). at Room No. 124, Department of Law, University of Mumbai, Fort, Mumbai.

Candidates are required to bring original documents and one set of attested xerox copy of the following documents at the time of Interview for the purpose of verification and submission:

- All LL.M Marksheets and Passing & Degree certificate - candidates whose marksheets are in reserve or on hold are required to get the stamp and signature of the Principal of the concerned Law College on Gazetted copy of the declared result.
- Copy of eligibility certificate Ph.D. Entrance in Law (conducted by the University Of Mumbai).
- Copy of eligibility certificate of NET/SET/ JRF/ M.PHIL , if applicable.
- Reserved category: - Caste Certificate & Caste Validity Certificate (if having) issued by the Government of Maharashtra , if applicable.
- Valid Non-Creamy layer certificate:- candidates belonging to OBC,SBC,VJNT,NT-A,B,C,D backward classes needs to submit valid Non-Creamy layer certificate issued by the Government of Maharashtra. Or copy of valid receipt of application made for Non-Creamy layer certificate issued by the Government of Maharashtra, if applicable.
- Economically Weaker Section candidates :- candidates belonging to EWS category should submit EWS eligibility certificate issued by the competent authority of Government of Maharashtra, if applicable.
- Socially and Educationally Backward Classes candidates :- candidates belonging to SEBC category should submit SEBC eligibility certificate issued by the competent authority of Government of Maharashtra, if applicable.
- Valid Non-Creamy layer certificate:- candidates belonging to SEBC should submit Non-Creamy layer certificate issued by the Government of Maharashtra or copy of valid receipt of application made for Non-Creamy layer certificate issued by the

Government of Maharashtra, if applicable.

- Divyang candidate :- copy of Disability Certificate as per the Government norms , if applicable.
- Quota candidates:- (Freedom Fighter, Ex-serviceman, Sport, Cultural Activity, Orphan etc.) are required to submit certificate and relevant documents by competent authority wherever applicable.
- Change of name:- a copy of Gazette or Marriage Certificate in case of change of name.
- Equivalence Certificate, if applicable.
