To consider the recommendations made by the Board of Studies in German at its meeting held on 16th November, 2024 regarding the provision of counting teaching hours for various German extention courses for students of the M.A. German program as OJT for M.A in program from the academic year 2023-24.

Due to the unavailability of competent German teachers for our extension courses, we have been training our TYBA and MA students as teachers and giving the best ones teaching assignments in order to continue offering good quality of teaching for various German extension courses.

Hence, we need to count these German courses (120-150 hrs) as OJT, because if we do not, then the students already teaching extension courses will have to do extra 120 hrs as OJT outside the institution which will be overburdening them. If they leave teaching of extension courses, we have no teachers to teach.

Also, these student-teachers continue to teach at the Department even after completing MA - so it is in real sense OJT.

To count the hours of teaching by students of M.A. (German Studies), who teach German courses for the Department as OJT, from the academic year 2024-25.

In addition to this as per the resolution passed by the Board of Deans student should prepare one course of E-content as per the syllabus.
