### Introduction

The inclusion of field project in the learning process for the completion of the course is one of the ambitious aspects in the program structure. The key objective of including field work is to incorporate the element of research work, which will test the learner's eagerness to learn and capacity to describe specific aspects of the study in his/her perspective. The previous semester helped the learners to explore theoretical aspects, while this paper will help to test the acquired knowledge and the ability to apply the acquired knowledge to the real-life situations. This guide will provide you with the guidelines and the framework in which you are expected to submit your field project.

## **Guidelines for the Preparation of Field Project**

- The Field project topic may be undertaken from any topic given or related to respective subject.
- Each of the learners has to undertake a Project individually
- The learner must choose a topic and title that are precise, clear, and have a clear objective
- The Field Project will be evaluated for 100 Marks
- The report shall be prepared as per the broad guidelines given below:
  - The field project has to be submitted in the Handwritten Format on One Side Ruled A4 Sizesheets already provided in the project manual.
  - The field Project should be of 30-40 pages.
  - ➤ The Project shall be submitted in PDF format and uploaded on the link that will be provided by the service provider.
  - ➤ The Size of the PDF File should be between 15MB-20MB.
- Projects should be submitted within the time frame announced by the Institute.
- Any delays in the Project submission will not be entertained.
- In case of failing in the project work, the same project can be revised for ATKT examination.
- NO VIVA VOCE/PRESENTATIONS will be conducted by the Institute

- Scope of the Report: Define the boundaries of what the report will cover.

#### **Chapter 2: Literature Review**

Review relevant literature on the site(s) visited, focusing on previous studies, historical accounts, and critical analyses of the literary significance.

#### Chapter 3: Methodology

- Describe the approach and tools used for data collection during the visit (e.g., observational methods, interviews, archival research).
- Discuss the rationale behind the chosen methods.

#### Chapter 4: Field Work Descriptions, Observations and Analysis

- Provide detailed descriptions of each site visited/ Field work carried out.
- Include observations related to the Field work's relevance to topic selected.
- Use photographs, diagrams, and sketches, etc. to support the descriptions.
- OF MUMBP Analyze the data collected in relation to the study objectives.

#### **Chapter 5: Conclusion and Recommendations**

- Discuss how the findings from the visit contribute to the understanding of subject area.
- Summarize the key findings and their significance.
- Offer recommendations based on the research findings for further study or preservation efforts.

#### References

List all sources cited in the report in a consistent format.

#### **Appendices**

Include additional data, interview transcripts, notes, or documents that are relevant to the report but not integral to its main text.
