Amention of Head of the University Department of Education, the principals of the affiliated training colleges and the Director, Ali Yavar Jung Menonal Institute of Hearing Handicapped is hereby invited to the Ordinances, Regulations and Syllabi relating to the Bachelor of Education Hearing Impairment)B.Ed.(H.I.) vide Pumphlet No.86 under the revised pattern and to this office Circular No. UG/370 of 2003 dated 1st August, and they are hereby informed that the recommendation made by the Board of Studies in Education at its meeting held on 12th March, 2004 has been accepted by the Academic Council at its meeting held on 2nd April, 2004 vide item No.4.21 and subsequently approved by the Management council at its meeting held on 17th April, 2004, vide item No.20 in exercise of the powers conferred upon it under Sub Section (i) of section 55 of the Maharashtra Universities Act 1994, and that in accordance therewith Regulations 4315 and 4316 relating to the standard of passing at the Bachelor of Education (Hearing Impairment) B.Ed.(H.I.) has been amended to read as under:-

R.4315:- Appropriate class (Ist. IInd. Pass Class and failure shall be given combined for part A and part B).

R.4316:- With respect to total marks gained by the candidate in part A tout of 500) and part B (out of 500) one of the following corresponding classes will be accorded to the candidate:-

Fercentage of Marks	Class
44%	Fail
45% to 49%	Pass Class
50% to 59%	Second Class
60% to 74%	First Class
75% and above	Distinction

for the purpose of Co-ordination of Internal Assessment in Part B. there shall be a Co-ordination Committee consisting of:-

- (i) The Chairperson, Board of Studies in Education.
- (ii) The Chairperson, B.Ed.(H.I.) Examination of the concerned year,
- (iii) Two Principals, who are not the members of the Board of Studies in Education, nominated every year by the Board of Studies in Education.



(iv) Two members of the Board of Studies in Education who are not included in the above categories, nominated every year by the Board of Studies in Education.

The Committee shall go through internal assessment marks and the grades awarded to students of different colleges of education. If any discrepancy is found in the standard of marking and or of grading by college from the norms framed by the Board of Studies in Education, the Principals concerned would be required to accordingly modify the marks as per the directions given by the Co-ordination Committee. The committee is authorized to check all the internal work of the students of the college to verify the marks awarded by the college and make necessary changes. wherever required.

Further that the aforesaid Regulations will be brought into force with effect from the examination of the first half of the year 2004.
