

CIRCULAR :-

A reference is invited to the Ordinances, Regulations and syllabi relating to the Bachelor of Fine Art (B.F.A) (all branches) degree course vide this office Circular No. UG/ 210 of 2004 dated 28th May, 2004 and the Dean of the J. J. Institute of Applied Arts and the Dean of the J. J. School of Art are hereby informed that the recommendation made by the Board of Studies in Painting and Applied Art at its meeting held on 25th November, 2008 has been accepted by the Academic Council at its meeting held on 15th December, 2008 vide item No. 4.2 and subsequently approved by the Management Council at its meeting held on 22nd December, 2008 vide item No. 8 and that, in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 55 (1) of the Maharashtra Universities Act 1994, it has made Regulation 6062 relating to Class Improvement of B.F.A. examination to read as under :-

R.6062 :- The candidate who have passed the B.F.A. degree examination of this University with the class mentioned in the column 1 and who desires to improve their class as shown in column 2 below, will be permitted at their option to appear again for the Final Year of the B.F.A.(All Branches) degree examination with the same subjects (Theory, Practical and Oral) without being required to keep any terms.

Column 1	Column 2
(a) Pass Class	(a) Second Class or First Class
(b) Second Class	(b) First Class

This provision shall be applicable to subsequent only ONE consecutive examination conducted by this University. Marks obtained by the candidate in the term work/class work will be carried forward. If candidates who re-appear for the Four Year B.F.A. (All Branches) degree examination under the provisions of this Ordinance fail to improve their class, their performance at such re-appearance will be ignored.

The aforesaid Regulation relation to the Class Improvement is implemented from the examination to be held in first half of the year 2009.


