CIRCULAR :

Attention of Principals of the affiliated colleges in the faculty of Commerce and the Director, Institute of Distance Education are hereby invited to the Ordinances, Regulations and syllabi relating to the F.Y.B.Com. and S.Y.B.Com. degree course vide pamphlet No.141 and 142 and they are hereby informed that the recommendation made by the Board of Studies in Commerce at its meeting held on 15th December, 2003 has been accepted by the Academic Council at its meeting held on 3rd January, 2004 vide item No.4.44 and in accordance therewith has been made for those students who were admitted by certain colleges for the F.Y.B.Com. course (under the old pattern) prior to the academic year 2002-2003 and have not appeared for the S.Y.B.Com. examination, in the first term of the academic year 2003-2004, in the subject of Business Environment and Development as required by the University Circular No.UG/460 of 2003, dated 19th September, 2003 be asked to appear for Commerce Paper II – Business Environment and Development of 100 marks at the S.Y.B.Com. examination (under the old pattern) to be held in the first half of 2004 without keeping terms (as per the provision made in the said circular), in order to regularize their results at the S.Y.B.Com. examination as they have already appeared for the F.Y.B.Com. examination in the subject of Commerce Paper I – Fundamentals of Marketing and Finance, their appearance at the S.Y.B.Com. in the same subject cannot be taken into consideration for declaring their results at the S.Y.B.Com. examination.

Further that in partial modification of the University Circular No.UG/460 of 2003, dated 19th September, 2003, the examination in Commerce Paper I at the F.Y.B.Com. (under Old syllabus) and Commerce Paper II at the S.Y.B.Com. (Under Old Syllabus) be held for the last time as follows:-
