Sir,

I am to invite your attention to the Ordinances, Regulations and syllabus relating to the Master of Chemical Engineering degree course vide pamphlet No.189 and to this office Circular No.UG/9 of 2005 dated 5<sup>th</sup> January, 2005 and to inform you that the recommendation made by the Board of Studies in Chemical Technology at its meeting held on 9<sup>th</sup> December, 2004 has been accepted by the Academic Council at its meeting held on 5<sup>th</sup> January, 2005 vide item No.4.32 and subsequently approved by the Management Council at its meeting held on 18<sup>th</sup> February, 2005 vide item No.6 and that in accordance therewith the Regulations 4131 and 4132 relating to the M.Chem. Engg. degree course have been amended to read as under :-

**R.4131** : At the beginning of the first semester, every year, the Director of the Mumbai University Institute of Chemical Technology will notify to the candidate a subject or subjects of Electives, in the first week of commencement of Semester I, and if the number of subjects so notified is more than one, then every candidate registered for the degree will have to notify to the Director in writing the subject which he desires to offer for Semester I examination under the subject head 'Elective' from among the subjects notified by the Director. A comprehensive list of elective subjects has been given at the end. If a candidate fails to pass in the subject of Elective, the candidate will have to select a fresh Elective subject from amongst the subjects notified by the Director in that year for subsequent examination.

**R.4132** : At the beginning of the second semester, every year, the Director of the Mumbai University Institute of Chemical Technology will notify to the candidate a subject or subjects of Electives, in the first week of commencement of Semester II, and if the number of subjects so notified is more than one, then every candidate registered for the degree will have to notify to the Director in writing the subject which he desires to offer for Semester II examination under the subject head 'Elective', from among the subjects notified by the Director. A comprehensive list of elective subjects has been given at the end. If a candidate fails to pass in the subject of Elective, the candidate will have to select a fresh Elective subject from amongst the subjects notified by the Director in that year for subsequent examination.

Notwithstanding the provisions contained above, the students who are appearing for repeat examination of M.Chem. Engg. Degree course should be permitted to take their previous 'Elective' subject for repeat examination. Similarly, if a candidate fails in 'Seminar' Head or fails to appear for 'Seminar' presentation, at the M.Chem. Engg. examination and he/she is not eligible to appear for the corresponding repeat examination, such candidate shall be permitted to appear for the subsequent regular examination with the changed seminar topic and changed Elective subjects. Appearing at a repeat examination shall be optional.

Further that the amended Regulations 4131 and 4132 have been brought into force with effect from the academic year 2004-2005.
