I am to invite your attention to the Ordinances, Regulations and Syllabi relating to the Post-Graduate Diploma in Management of Insurance Sector (PGDMIS), Post-Graduate Diploma in Hospital Management and Health Care (PGDHM & HC), Diploma in Customs Clearance and Freight Forwarding (DCC & FF), Diploma in Foreign Trade Management (DFTM) and Diploma in Medical Radiography (DMR) vide this office Circulars No.UG/332 of 1998, dated 3rd October, 1998, No.UG/628 of 1999, dated 29th December, 1999, No.UG/239 of 2003 dated 9th June, 2003 and No.UG/352 of 2004, dated 21st August, 2004 and to inform that the recommendation made by the Academic Council at its meeting held on 13th April, 2007 vide Item No.7.3 and subsequently approved by the Management Council at its meeting held on 20th April, 2007 vide Item No.27 and that in accordance therewith Ordinances 5243 relating to the Post Graduate Diploma in Management of Insurance Sector (PGDMIS) and Ordinance 5454 relating to the Post Graduate Diploma in Hospital Management and Health Care (PGDHM & HC) are amended to read as under :-

O.5243 : Post Graduate Diploma in Management of Insurance Sector (PGDMIS)

Eligibility :-

Graduate from recognized University

O.5454 :- Post Graduate Diploma in Hospital Management and Health Care (PGDHM & HC)

Eligibility :-

M.B.B.S./B.A.M.S./B.H.M.S./B.D.S. OR equivalent
OR allied recognised by the University OR Degree
in Nursing (Recognised by University) and experience
of 5 years OR B.A./B.Com./B.Sc. and Five Years
experience in Health Care field/Hospital.

Further that Ordinance 5709 relating to the Diploma in Customs Clearance and Freight Forwarding (DCC & FF), Ordinance 5710 relating to the Diploma in Foreign Trade Management (DFTM) and Ordinance 5711 relating to the Diploma in Medical Radiography (DMR) are passed as under :-

- (1) Diploma in Customs Clearance and Freight Forwarding (DCC & FF)

O.5709 : Eligibility :-

H.S.C. OR Equivalent OR S.S.C. OR Equivalent with three years Experience in Organisation handling goods through Customs Clearance .

(2) Diploma in Foreign Trade Management (DFTM) :-

O.5710 :- Eligibility :-

H.S.C. or Equivalent examination

(3) Diploma in Medical Radiography

O.5711 :- Eligibility :-

H.S.C. OR S.S.C. with 3 years experience in Public Hospitals.

Further that in exercise of the powers conferred upon the Management Council under Section 54(1) of the Maharashtra Universities Act 1994, it has made the amended Ordinances 5243, and 5454 relating to the Post Graduated Diploma in Management of Insurance Sector (PGDMIS), Post Graduate Diploma in Hospital Management and Health Care (PGDHM & HC), will be brought into force with effect from the academic year 2007-2008.

Further that in exercise of the powers conferred upon the Management Council under Section 54(1) of the Maharashtra Universities Act 1994 it has made the new Ordinances 5709, 5710 and 5711 relating to the Diploma in Customs Clearance and Freight forwarding (DCC & FF), Diploma in Foreign Trade Management (DFTM) and Diploma in Medical Radiography (DMR) will be brought into force with effect from the academic year 2007-2008
