CIRCULAR :

In partial modification of this office Circular No.UG/525 of 2004, dated 2nd December, 2004, the Principals of the affiliated colleges in Arts and the Director, Institute of Distance Education are hereby informed that the report of the Vice-chancellor of the action taken by him in exercise of the powers conferred upon him under Section 14(7) of the Maharashtra Universities Act, 1994 in accepting the following recommendation made by the Board of Studies in History and Archaeology at its meeting held on 21st October, 2004 has been approved by the Academic Council at its meeting held on 14th December, 2004 vide item No.7.4 :-

1. That the guidelines for setting at question paper at the T.Y. B.A. examination in the subject of History Paper VI-Option 'B' be as follows :-
 - a. As there are three Sections in this paper, there would be three questions from each of the Section, of which two would be essay type questions and one would be short note.
 - b. A candidate will have to attempt one question from each Section.
2. That text book 'Contemporary World' – P.C. Joshi, Adhunik Jagacha Itihas, Mangesh Prakashan be prescribed in the list of text books in the subject of History Paper VIII at the T.Y.B.A. examination.
3. That the distributions of marks in the subject of History Paper IX-Current Affairs, at the T.Y.B.A. examination be as follows:-
 - a) General Knowledge-40 Marks
 - b) Current Affairs: Socio, Economic & Political – 30 Marks.
(National and International events).
 - c) Concepts-20 Marks.
 - d) Project – 20 Marks.

The above recommendations have been brought into force with effect from the academic year 2004-2005.
