

All the Principals of the affiliated colleges, the Directors of the Recognized Institutions, Heads of the University of Mumbai, Director, Thane Sub-Campus, Director, Kalyan Sub-Center, Director, Ratnagiri Sub-Centre are hereby informed that the recommendations of the Board of Studies in Environmental Studies at its meeting held on 15th April, 2025 vide item No. 1 and subsequently passed by the Board of Deans at its meeting held on 19th May, 2025 vide item No. 8.14 (N) are accepted by the Academic Council in its meeting held on 20th May, 2025 vide item No. 8.34 (N) regarding adoptions for UGC Compulsory Curriculum and Credit Framework for Undergraduate Programmes for Environmental Education.

The proposed credit distribution across semesters shall be as follows:
